Qualifications

You need a degree or combination of education and experience as described below to qualify for this position.

Mathematical Statistician - You must have a bachelor's degree from an accredited or pre-accredited college or university that **included** 24 semester hours of mathematics and statistics, of which **at least** 12 semester hours were in mathematics **and** 6 semester hours were in statistics; **OR** a combination of education and experience that includes this education.

Statistician- You must have a bachelor's degree from an accredited or pre-accredited college or university that **included** 15 semester hours in statistics (or in mathematics and statistics, provided at least 6 semester hours were in statistics), **and** 9 additional semester hours in either physical, biological, or social sciences.

As part of the application process, you are required to submit college transcripts or a list of courses as described in the Required Documents section of this announcement. However, if you are selected, you must provide official educational transcripts before you start work with EPA. In addition to the educational requirements, we are looking for at least one year of specialized experience related to this position as described below:

To qualify for the **GS-14 level**, you need to have at least one year of full time experience equivalent to the GS-13 level defined as conducting risk assessments using quantitative methods and working as part of an interdisciplinary team; developing quantitative risk analyses in collaboration with other team members and explaining these analyses to managers and/or decision makers.

Your answers to the on-line assessment will be used to evaluate your competencies in the following areas: **1)** Ability to lead assessment projects; **2)** Skill in applying existing and new quantitative methods for health risk assessments; **3)** Ability to provide leadership, training, and mentoring for staff; **4)** Ability to identify, develop, and/or apply quantitative methods and approaches that will improve human health risk assessments; **5)** Ability to develop, conduct, and lead research projects; **6)** Ability to provide reviews and evaluations of assessments, and technical analyses; **7)** Ability to provide advice on quantitative, technical and scientific matters in response to requests by individuals or organizations.

Experience refers to paid and unpaid experience, including volunteer work done through National Service programs (e.g., Peace Corps, AmeriCorps) and other organizations (e.g., professional; philanthropic; religious; spiritual; community, student, social). Volunteer work helps build critical competencies, knowledge, and skills and can provide valuable training and experience that translates directly to paid employment. You will receive credit for all qualifying experience, including volunteer experience. If you are selected, you must complete a one year probationary period.

This position is designated as Moderate Risk and requires a background investigation. Unless an appropriate background investigation is already on record with the Office of Personnel Management, you must undergo a background investigation.
